Day 2: Practical Canine Locomotion: Gaits of the Dog; Principles of Judging Movement; Locomotion and its Dynamics; Sustained Trotting Styles; Trotting Styles for Galloping Breeds; Trotting Styles for Special Purposes. Evaluation of Dogs.

**Dogs for Evaluation: The owner must have been in dogs for at least 5 years. Dogs shall be show quality dogs between 18 months and 8 years of age and show ring trained. Finished Champions preferred.**

He has judged specialties and all-breed shows and conducted educational programs in the United States, Australia, Canada, Finland, Israel, the Republic of Korea, New Zealand, and judged in Hong Kong and Taiwan.

She continued to participate in AKC, Canadian Kennel Club (CKC), and International events as a breeder and exhibitor of champion Borzois, Salukis, and Boxers, and as an all-breed professional handler. Pat is an approved (2004) AKC Junior Showmanship judge and (1996) CKC Hound Group judge including Finnish Spitz. She is also approved (2005) to judge Affenpinschers, Cavalier King Charles Spaniels, Chihuahuas (Long & Short Coats), Chinese Crested Dogs, English Toy Spaniels, Griffons (Brussels), Italian Greyhounds, Maltese, Miniature Pinschers, Pekingese, and all Poodles (Toy), (Miniature), (Standard). She is on permit (2005) for the balance of the Toy Group including Xoloitzcuintli (Toy). She is AKC approved (2005) for Afghan Hounds, Borzois, Salukis. Pat is AKC provisional for Basset Hounds, Dachshunds, and Rhodesian Ridgeback. Pat has judged in the United States, Canada, Australia, and the Republic of Korea.
